

Certified Pool-Spa Operator® Class Registration Form 2018



The Certified Pool-Spa Operator® program has delivered more training than any other program in the pool and spa industry since 1972. It is widely accepted by both health departments and state agencies throughout the United States and 43 countries. The CPO® program is the leading education and certification program for pool/spa operators, providing frontline defense to protect the public.

My name is Brent Brockmeyer, and I am an instructor for the CPO® certificate. The program provides for 14-16 hours of instruction over two days, with the option for a three-day class that is more detailed. The course includes pool and spa water chemistry, water testing and treatment, filtration, maintenance, automated systems and government requirements.

To receive the certificate, class participants must pass a required open-book exam. Upon passing the test, a certificate valid for five years is issued by the National Swimming Pool Foundation®. The registration fee includes the class manual and all certification fees.

Classes in Branson are held at Castle Rock Resort and Waterpark. A special rate of \$69 per night plus tax is available. You must mention you are a CPO student when making the reservation. The Castle Rock number is 417-336-6000. Address is 3001 Green Mountain Dr.

All other classes will have the location forwarded upon registration.

Two-day classes are \$350. Three-day classes are \$425 and cover the same material in greater depth. Please register at least 2 weeks prior to the class you choose, so books and information reach you in plenty of time.
